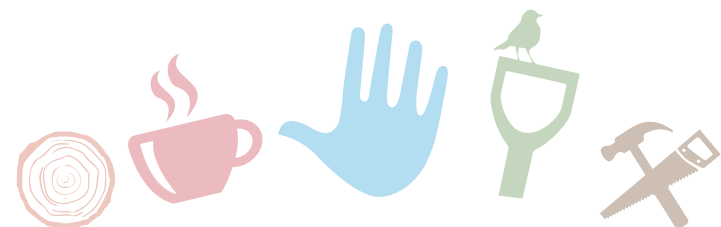

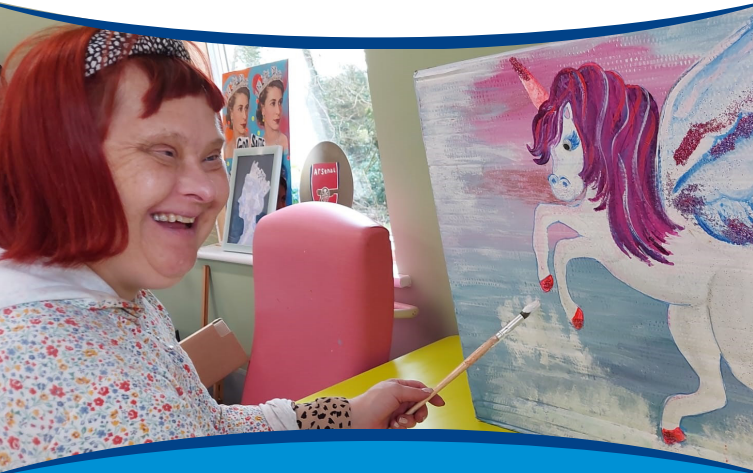
Become a Friend of The Fifth Trust
